## **Description and Relevance of Holding:**

The John F. Kennedy/Dallas Police Department Collection contains 11,406 documents and photographs, including homicide reports, affidavits, witness statements, newspaper clippings and correspondences. The collection is available on microfilm. The Municipal Archives possesses the original files, except those that have been transferred to the federal government permanently. In 1989 the Dallas Police Department transferred all police records relating to the assassination to the Office of the City Secretary at the Dallas Municipal Archives.

<u>Aviation Director Files on President John F Kennedy Visit</u> contains contains schedules, notes, and other preparatory materials for President John F. Kennedy's visit to Dallas on November 22, 1963. It includes an assignments list, aviation director's notes, ephemera, and contact information regarding the president's visit.

<u>William Oren Trogdon John F. Kennedy Assassination Research Collection</u> contains entirely photocopied records from the Dallas Police Department.

The <u>Fort Worth History Center</u> contains documents, pamphlets, clippings, photographs, and books on the Warren Commission and Marguerite Oswald's testimony. Of special interest is the fourth grade photo of Lee Harvey Oswald at Ridglea West Elementary School in Fort Worth in 1949-1950. Many of the clippings were deposited and annotated by Marguerite C. Oswald.

#### **Description and Relevance of Holding:**

<u>The Alex Arroyos Photograph Collection</u> consists of 8x10 black and white photographs. The photos taken by Alex Arroyos depict President John F. Kennedy, Jackie Kennedy, Vice President Lyndon Johnson, and Lady Bird Johnson at a meeting of LULAC (League of United Latin American Citizens) at the Rice Hotel in Houston on the night of November 21, 1963.

The <u>John J. Herrera</u> collection contains the following materials about John F. Kennedy: five 8x10 prints and one newspaper image cut out. The photos are of the speech John F. Kennedy gave at the Rice Hotel in 1963.

The <u>J. A. "Tony" Alvarez</u> Papers contains the following materials about John F. Kennedy: 10 photos in a photo album from the November 1963 Speech that John F. Kennedy gave at the Rice Hotel.

<u>Record Group 21 and Record Group 118 from U.S. District Court for the Northern District of Texas, Dallas Division</u> contains manuscripts, documents, and photographs. Microfilmed and identified as Microfilm 7RA-30B. This material relates to Marina Oswald Porter and the rifle used in the Kennedy assassination. John King apparently tried to purchase the rifle and the U.S. government confiscated it. Companion records are located in the National Archives-Rocky Mountain Region, Denver.

### **Description and Relevance of Holding:**

The Sixth Floor Museum holds a collection of approximately 95,000 historical items—ranging from three-dimensional artifacts of all sizes, still and moving images, manuscripts and documents, audio and visual recordings including early 1960s television and radio broadcasts and home movies, newspapers and magazines, over 2,000 oral history interviews, and other documentation and ephemera related to the assassination and legacy of President John F. Kennedy, the cultural legacy and continuing impact of the events of November 1963, the social history of mid-twentieth century Dallas both before and after the assassination, and the history of Dealey Plaza, the Texas School Book Depository building and the John F. Kennedy Memorial.

## **Description and Relevance of Holding:**

<u>The Stanley Marcus Papers</u> are currently being processed. Marcus was the President of Neiman Marcus, and an active community leader in Dallas during the 1960s.

<u>The Earl Cabell Papers</u> includes the correspondences and letters of Earl Cabell, the mayor of Dallas during the assassination.

<u>The Belo Records</u> include correspondence, private and business papers of the Dealey family from 1842-2007, *Dallas Times Herald* photographs and materials.

<u>Scrapbook of John F. Kennedy</u> contains newspaper clippings of the assassination and investigation.

<u>The Blackie Sherrod Papers</u> includes the articles and letters of Blackie Sherrod, a noted Texas sports writer and covered the assassination for the *Dallas Times Herald*.

#### **Description and Relevance of Holding:**

<u>Senator John G. Tower Papers</u> is approximately 800 linear feet, consisting primarily of materials that Senator Tower accumulated during his 24 years in the Senate. Senator Tower was a leader in Republican Party politics in Texas and on the national level. The collection has a few Kennedy items, of special note are photocopies of correspondence between Senator Tower, Oswald and the State Department. Oswald contacted Tower, his senator, when Oswald was trying to return to the United States from the Soviet Union, and one folder contains copies of related correspondences. The second folder contains letters from citizens responding to the assassination, including several telegrams and letters blaming the "John Birchers" and "ultra-right wingers" for Kennedy's death.

#### **Description and Relevance of Holding:**

The Marguerite Oswald Collection\_contains manuscripts from press conferences, lectures, radio programs, legal documents, letters, photocopies of Lee Harvey Oswald letters, scrapbooks, sound recordings, photographs, drawings, ephemera, personal records, annotated articles, and publications by Marguerite. Items within the Marguerite Oswald Collection provide a glimpse into the life and character of Lee Harvey Oswald through portraying those of his mother. This collection evolved through Marguerite's efforts to prove her son innocent of involvement in the assassination or that he was a small part of a conspiracy. Mrs. Oswald, secondarily, did attempt to generate income using her collection of assassination material, hence certain original documents are missing. Papers, books, and publications annotated by Mrs. Oswald reveal her personality.

<u>The Jim Wright Collection</u> contains a letter sent to Speaker Wright a year or two before the assassination from Marguerite Oswald asking for help finding Lee Harvey Oswald in the Soviet Union. A detailed <u>finding</u> aid is available for this collection.

#### **Description and Relevance of Holding:**

<u>The John F Kennedy and Dallas Police Department Photograph Collection</u> contains 404 photographs that include the "sniper's nest" in downtown Dallas' Texas School Book Depository Building, where Oswald allegedly fired on Kennedy's motorcade; the back and front yards of the boarding house at 214 Neely; Dealey Plaza; the intersection at Tenth Street and Patton Avenue where Oswald allegedly fatally shot Dallas patrolman J.D. Tippit; interiors of the Texas Theater, where Oswald was arrested by Dallas police; and the basement of Dallas City Hall, where Jack Ruby shot and killed Oswald on Nov. 24, 1963.

<u>The John F. Kennedy Memorial Collection</u> contains newspapers, correspondence, legal documents, police reports, photographs, and video footage documenting the weekend of President Kennedy's assassination as well as the subsequent investigations into both Lee Harvey Oswald and Jack Ruby.

<u>The Jim Marrs Collection</u> contains Personal notes, writings and correspondence, articles, publications, photographs, slides, videos, audio recordings, books and posters resulting from journalist and author (Crossfire: The Plot That Killed Kennedy) Jim Marrs' career and research. Marrs specialized in reporting on conspiracy theories and government cover-ups.

<u>The Judge Sarah T. Hughes Collection</u> Sarah Tilghman Hughes (1896-1985) practiced law in Dallas, and was the first woman to serve as a federal district judge in Texas (1961-1975; senior status until 1982), and championed various human and women's rights causes. Notably, as a federal district judge, Hughes administered the presidential oath of office to Lyndon B. Johnson aboard Air Force One following the assassination of John F. Kennedy in November 1963.

<u>The Charles Reagan Papers</u> contains the research of Charles E. Reagan, Jr., who was working on a book about John F. Kennedy and the era surrounding his presidency. Items include his hand-written notes and manuscript on notepads, printed articles, magazines, and newspapers featuring Kennedy, and typed manuscript pages.

### **Description and Relevance of Holding:**

<u>UA 016-19 The President John F. Kennedy Assassination Collection</u> includes articles and press coverage of the assassination.

<u>UA010-12 Graduate Research Center of the Southwest (GRCSW)/Southwest Center for Advanced Studies (SCAS) Collection</u> contains material about the Graduate Research Center of the Southwest planning for a luncheon which the President was on his way to attend at the time of the assassination. It includes planning memos, correspondence, invitation to the events, and a copy of the speech the President was scheduled to deliver.

<u>UA015-19 The University of Texas at Dallas Oral History Collection</u> contains an oral history by Densie Hales, wife of Professor Anton Hales in which she describes attending the luncheon and hearing about the assassination.

## **Description and Relevance of Holding:**

<u>The John F. Kennedy Collection</u> contains Memorabilia concerning the President's visit to Texas, including the text for two speeches Kennedy intended to deliver in Dallas and Austin.

<u>The JFK Assassination Collection</u> contains one of the sets of materials assembled by Texas Attorney General Waggoner Carr.

<u>The Ralph Yarborough Papers</u> are 1400 linear feet of records documenting the career of the senior senator during the Kennedy years.

<u>The Joe Kilgore Papers</u> contain the papers of South Texas district Congressman Kilgore, including constituent mail from the assassination and its effect upon the district.

<u>The Earl C. Kubicek Collection</u> includes books, magazines, news clippings, pamphlets, government reports, typescripts of transcribed radio interviews, and scrapbooks concerning the assassination. Earl C. Kubicek was a private JFK collector from Santa Fe, NM.

<u>The Edith Parker Collection</u> includes personal, professional, and political correspondence, literary productions, education and employment records, photographs, other pictorial material, and a map. Edith Parker had close ties with LBJ and served on a committee chaired by JFK.

<u>The Richard M. Morehead Papers</u> contains the files of a longtime *Dallas Morning News* reporter and columnist who covered Texas politics during the Kennedy-Johnson years.

<u>The Harry Estill Moore Papers</u> contains the correspondence and research of a noted University of Texas sociologist who studied the effect of momentous events such as floods, hurricanes, tornadoes, and integration on Texas society.

<u>Henry B. Gonzalez Papers</u> contains materials related to Gonzalez as co-chair of Kennedy's "Viva Kennedy" effort. The collections also includes Gonzalez's effort to establish a congressional committee to investigate the assassinations of President John F. Kennedy and civil rights leader Martin Luther King, Jr.

materials related to Goodwin's career as a speech writer and assistant to political figures including John F. Kennedy, Lyndon B. Johnson, and Robert F. Kennedy.
